1. area acting social worker from the Department for social affairs, town of Backa Topola, responsible for welfare of socially deprived people;
1. *područno nadležnog radnika Centra za socijalni rad, Backa Topol, odgovornog za brigu o socijalno ugroženim ljudima ;*
2. person in charge on behalf of Local Municipality Backa Topola who is responsible for legal care of unwanted pets – by the law it is forbidden to use method of killing known as ‘euthanasia’ – as recorded by the decision of Supreme Court IU 27/007’
2. *odgovornog lica opštinske uprave Backa Topola ,koje je odgovorno za zakonito zbrinjavanje napuštenih kućnih ljubimaca – zakonom je zabranjeno ubijanje pod imenom `eutanazija` - dokaz Zaključak Ustavnog suda IU 27/2007;*
3. area-acting veterinarian inspector responsible for providing the assistance in implementation of Veterinary Laws And Law about Animal welfare who did not carry out his lawful duty;
3. *područno-nadleznog veterinarskog inspektora ,odgovornog da omogući nadzor implementacije Zakona o veterinarstvu I Zakona o dobrobiti životinja, jer nije obavljao službenu dužnost;*
4. person in charge from the Department of Inspection Duties, Board of Veterinary - Ministry of Agriculture for the Republic of Serbia, who tolerates the disrespect of current legislation;
4. *odgovornog lica Odeljenja za Inspeksijske poslove Uprave za veterinu Ministarstva poljoprivrede RS, jer je tolerisalo nepostupanje .*
5. person in charge from local community services inspection, Backa Topola;
5. *odgovornog lica lokalne komunalne inspekcije , Backa Topola;*

Persons named above with their failure to act purposely left Ms. Etela Merk in the circumstances in which she lost her life on the 07.03.2011 and considerable number of animals were harmed or killed. They failed to provide their legal duty in conjunction with current laws of Republic of Serbia and with failure to act caused that Ms. Etela Merk with her under age child were left neglected for years and on their own, while trying to look after unwanted pets. On numerous occasions she demanded law implementation and she sent numerous requests to Serbian Public and Local Councils, as the care for unwanted pets falls in within the remit of Local Municipalities. Ministry of Agriculture has a legal obligation to supervise implementation of Veterinary Laws and the Laws for Animal welfare. Department for Social Welfare also has a legal obligation to care about people with needs, especially if underage children are involved but Ms Etela Merk and her under age child were left for years to look after themselves and with no help from social service. They had to survive on the ranch with 400 pets belonging to irresponsible citizens from town of Backa Topola.

We now have information that local Council has intention to carry out another criminal act and kill the great number of animals that so far Ms Etela Merk was looking after.

This is why we are pointing out to the Prosecuting Office that we will request responsibility for every single life taken and in this case we will carry out all necessary investigations for obtaining the proof that indicates use of euthanasia. This will serve as evidence for criminal act of killing and it differs from legal implementation of euthanasia in accordance with law.

zbog toga sto su necinjenjem namerno ostavili g.Etelu Merk u situaciju u kojoj je 7./ 8.3.2011. izgubila zivot,kao I veci broj zivotinja , jer nisu obavljali svoju sluzbenu duznost u skladu s vazecim zakonima Republike Srbije , usled cega je zbog njihovog necinjenja g.Etela Merk sa svojim maloletnim detetom godinama bila prepustena sama sebi u obavljanju poslova zbrinjavanja napustenih kucnih ljubimaca, premda je bezbroj puta trazila zakonito postupanje i slala apele javnosti Srbije I lokalnoj vlasti , jer je zbrinjavanje napustenih kucnih ljubimaca zakonska obaveza jedinice lokalne samouprave, kao sto je zakonska obaveza Ministarstva poljoprivrede da putem inspekcijskih sluzbi nadzire primenjivanje Zakona o veterinarstvu I Zakona o dobrobiti zivotinja ,,a obaveza je Centra za socijalni rad da odgovorno brine o ljudima sa socijalnim potrebama pogotovo ako su prisutni I maloletnici – a g.Etela Merk I njeno maloletno dete su godinama prepusteni sami sebi I bez ikakve pomoci ziveli na salasu sa 400 kucnih ljubimaca koji su vlasnistvo neodgovornih gradjana Backe Topole .

Takodje imamo saznanje da lokalna vlast namerava pociniti jos jedno krivicno delo : ubijanje velikog broja kucnih ljubimaca o kojima je do sada umesto njih bila primorana da brine g. Etela Merk ,stoga sada skrecemo paznju javnom tuzilastvu da cemo traziti odgovornost za svaki oduzeti zivot u ovom slucaju I dokaze indikovanosti svake eutanazije . Dokaz indikovanosti cini razliku izmedju zakonite eutanazije I krivicnog dela ubijanja u suprotnosti s propisima .
